


GRAND LODGE OF MASONS IN MASSACHUSETTS

George H. Taber Lodge Helps Those With No One

Members of George H. Taber Lodge got into the Christmas spirit at the Fairhaven Old-Time Holiday Fair on December 10th. Twenty years ago, Rt. Wor. Eric Berg, current Worshipful Master of the George H. Taber Lodge, came up with the idea to sell cookies that will be delivered as gifts to nursing home residents without family. The booth has been a fixture at the fair ever since. Three nursing homes in the area supply the lodge with a list of over 80 names. When the cookies are bought at the fair, they are pre-labeled with the recipient's name and nursing home location. The buyers handwrite their name or message under the "From:" on the label. The cookies always sell out quickly thanks to the outpouring of kindness and generosity within the community.

I'm sure you've seen the building. It is right across the street from the Grand Lodge entrance on Boylston Street. It's designed in the High Victorian Gothic style, with a multicolored sandstone street facade and once even sported a short clock tower. It's pretty, but the thing that caught and held my attention was not its design, but the words inscribed above the front door: Boston's Young Men's Christian Union.

What was the YMCU, I wondered? A predecessor of the Young Men's Christian Association? Were they somehow related? I even found myself jokingly rewriting the lyrics to the 70's disco hit to the mysterious name

on this building. Doing a little research, I discovered a surprising link to my faith tradition. In the decades before the U.S. Civil War, there was a religious trend known as Muscular Christianity. It hoped to inspire a more masculine form of Christianity, that through athleticism, a strong moral worldview would develop. In 1851, the YMCA arrived in Boston from Great Britain and set up shop with a gym, as well as a place for bible study, and other educational pursuits. The problem was that their membership was exclusively for evangelical protestants, excluding two important religious groups in Boston at that time, Jews and Unitarians.

Soon, two new organizations began, the Young Men's Hebrew Association, who built their own

building in Roxbury, and the YMCU. By 1875, the Union built their building to provide many of the same sorts of services that one would find at the YMCA at the time, and for many decades it was a growing concern. Eventually, however, the things that it provided began to fall out of fashion, and they closed. The building is now being used by St. Francis House, providing affordable housing to the previously homeless.

When I look at that building today, I see an interest-

ing structure with an interesting history. I see a tale of a religious minority not bending to the whims of a larger institution. Mostly I see a lot of missed opportunities. We live in a time when it is easy to see the fraying of our social fabric, where it is easy to live in our own bubbles, separated from those who seem different from us. It is easy to let the opinions of the world influence our understanding of our neighbors, to pick a side and stick to it, but that is not what I believe God wants.

The first scripture we hear while in lodge is the 133rd Psalm, "Behold how good and how pleasant it is for brothers to live in unity." One of the things about

our Fraternity is that it brings men of different opinions together with a purpose larger than ourselves. As P.J. Roup, editor of the *Northern Light* magazine wrote, "When we focus on unity of purpose, we have less time to be concerned with the hows and whys that can easily divide us." Or as a brother in my lodge says with a wink, "In Freemasonry we become friends with men long before we realize that we don't like their politics."

The Masonic scholar and minister the Rev. Joseph Fort Newton once wrote, "Masonry was not made to divide men, but to unite them, leaving each man free to think his own thoughts and fashion his own system of ultimate truth. All its emphasis rests upon two extremely simple and profound

principles, love of God and love of man."

May the harmonizing lessons, ever present in our rituals, point us toward the truth that God wants us to be united in our thoughts, words, and actions, bringing support to all those with whom we share this world.

THE DECEMBER 2022 QUARTERLY COMMUNICATION





The Grand Master of Masons in Massachusetts, Most Worshipful Richard Maggio, on December 14, 2022, at 1:30 p.m., convened his last Quarterly Communication of the Grand Lodge of Masons in Massachusetts as Grand Master. The assembled Brethren, with a standing ovation, clapped and cheered as he entered.

"Our Colors will be presented today by the Aleppo Shrine Minutemen," announced the Grand Master. After a heartfelt Pledge of Allegiance to the flag and a rousing national anthem, the Grand Master introduced Captain John Wilder, who in turn introduced the other Nobles: Pvt. Robert Havener, Pvt. Carlos Ramos Rivera, Pvt. Peter Mooradian, Pvt. Jonathan Buck, and Pvt. David Gasson. After the Color Guard retired, the Brethren sang the hymn, "Oh God Our Help in Ages Past." Grand Chaplain, Rt. Wor. Benjamin Flax offered a prayer. "I declare a Regular Quarterly Communication of the Most Worshipful Grand Lodge of Masons in Massachusetts opened in ample form," the Grand Master gaveled the Quarterly open.

"Welcome Brethren," said the Grand Master, "It now gives me great pleasure to introduce those guests who were invited to join us today."



"Please join me in wishing Bro. John Driscoll a very Happy Birthday," announced the Grand Master. He led the Brethren in singing "Happy Birthday."

M. Wor. Bro. Ames explained the voting powers of the lodges and announced the recognition of Proxies which was submitted, seconded, and approved. "Brethren, this is the last chance for your lodge to pick up ballots in Doric Hall," said the Grand Master, "We will take a very short 5-minute break for any lodges who have not yet picked up their ballots."

Upon returning from the break, Deputy Grand Master Rt. Wor. John F. Sullivan read the necrology of our Brethren who have passed. The four new Brethren of the Celestial Lodge made those of us here poorer by taking with them over 275 years of Masonic experience. Grand Chaplain Emeritus, Rt. Wor. Keith Alderman offered a prayer for the departed.

The Grand Master opened the vote for his successor as Grand Master. "The candidate for Grand Master is Right Worshipful George Forrest Hamilton. Are there any nominations from the floor? Hearing none, I declare the nominations closed," said the Grand Master. "Rt. Wor. Grand Marshal, you will conduct the candidate out of the Lodge Room." The Grand Marshal escorted Rt. Wor. Bro. Hamilton from the room to a thunderous applause.

The Grand Master declared the ballot open. After voting and collecting the ballots, the Grand Master declared the ballot closed. "I appoint a committee of Past Grand Masters to count the ballots. As Chairman of the committee, I appoint the Senior Past Grand Master present, M.W. Albert T. Ames."

The Grand Marshal escorted the Past Grand Masters from the lodge room to the counting room.

During the counting, Rt. Wor. W. Warren Richardson, Jr. reported from the Records Committee and Rt. Wor. Robert V. Jolly, Jr. reported on the Committee on Charters and By-Laws - three approvals and one partial rejection. Both reports were approved.

After a brief musical interlude, the count was completed. The Grand Marshal conducted the Committee of Past

Grand Masters to the west of the altar to announce the results. Despite "one hanging chad," M. Wor. Bro. Ames announced the election of Rt. Wor. Bro. Hamilton as the next Grand Master of Masons in Massachusetts. Rt. Wor. Bro. Hamilton humbly accepted the position as the 91st Grand Master of Masons in Massachusetts to the cheers of all the Brethren present.

"Rt. Wor. Grand Sword Bearer, you will present to me Rt. Wor. John Emerson Kelley, Jr., our candidate for Senior Grand Warden," announced the Grand Master. The Grand Sword Bearer conducted the candidate from the lodge room and the Grand Master declared the ballot open. Once all the ballots were collected, the Grand Master appointed a committee of Past Senior Grand Wardens to count the ballots. The Chairman, M. Wor. Bro. Ames, and the committee were escorted from the lodge room to the counting room. Once the ballots and committee left the lodge room, the candidate returned.

Upon his return, the Grand Master called for the report from the Committee on Foreign Relations, from M. Wor. Bro. Hicks. He reported that The Grand Orient de Minas Gerais, Brazil, requested recognition, which was granted. He also reminded that, "It is important that no lodge under the jurisdiction of this Grand Lodge admit any brother from a lodge that is not listed in the The Acacia Book, published by Copiri, Inc., in Wilmington, Delaware. This book replaces the book titled List of Lodges - Masonic, published by Pantograph, in Bloomington, Illinois." The motion for acceptance was approved.

The Grand Master called the Committee of Past Senior Grand Wardens to be escorted to the west of the altar for their report of the count. M. Wor. Bro. Ames announced the election of Rt. Wor. John E. Kelley as Senior Grand Warden, which, when asked by the Grand Master, he humbly accepted.

The Grand Master brought the candidates for Junior Grand Warden, Rt. Wors. Alfredo J.R. Canhoto and Christopher Anthony Tonini, to the East. Both were escorted from the lodge room and the ballot was opened. Upon all

having voted, the Grand Master closed the ballot. The Grand Master created a committee of Past Junior Grand Masters to be chaired by Rt. Wor. Christopher M. St. Cyr. They retired to the counting room. The candidates were returned to the lodge room.

M. Wor. Bro. Ames presented three Petitions for Merger: William Sewall Gardner-Kilwinning Lodge and Pentucket Lodge, to operate under the name of Pentucket Lodge; Occidental Lodge and Wisdom Lodge, to operate under the name of Wisdom Lodge; and North Reading Lodge and Samuel Crocker Lawrence Lodge, to operate under the name North Reading Lodge. After a motion and a second, the Grand Master accepted the Petition for Mergers.

The Grand Master directed the Grand Marshal, the Senior Grand Warden Elect, to present M. Wor. Bro. Ames to the East for a presentation to the Grand Master, a certificate of appreciation from the Masonic Service Association. "I'm going to take you back myself," said the Grand Master. "Oh, is that something else I can't do?" he joked with the Brethren. "On your last day in Masonry, you can do anything you want," quipped M. Wor. Bro. Ames as he took his seat.

The Grand Master called for representatives from Mystic Valley and Meridian Lodges in commemoration, celebration, and congratulation for their 225th Anniversaries.

The Grand Tyler announced the count was complete. The committee was escorted back into the lodge room to the west of the altar. Rt. Wor. Bro. St. Cyr announced that Rt. Wor. Bro. Canhoto had been elected to the position of Junior Grand Warden. The Grand Master thanked and dismissed the committee. The candidates hugged, congratulated, and consoled each other. Rt. Wor. Bro. Canhoto was escorted to the East and humbly accepted the position.

The remaining ballot being unopposed, M. Wor. Bro. Ames moved that the rest of the candidates can be elected by the casting of one ballot by the Grand Secretary. The motion was seconded and passed. The Grand Secretary cast the ballot.

The Grand Master made a special presentation "to a Brother, who has surpassed most, if not everyone in Massachusetts Masonry, with regard to his help with the American Red Cross. His dedication at Wamesit Lodge in Tewksbury has resulted in record numbers of blood drives and donations to the Red Cross from the Tewksbury Masonic Building. To my knowledge he has orchestrated more blood drives and his actions have resulted in thousands of units of blood collected since the pandemic and led the Commonwealth by opening the Tewksbury Building during the pandemic. Rt. Wor. Grand Marshal, you will conduct Wor. David Howard Hicks to the East." In the absence of Wor. Bro. Hicks, the Grand Master noted that he would make the presentation at Wamesit Lodge.

The Grand Master noted his intent to present a Certificate of Appreciation to Bro. and Brigadier General Enoch Woodhouse, a Tuskegee Airman who was commemorated at the arrivals level of Terminal C of Logan Airport. He suggested all Masons see the mural.

The Grand Master called the following to the East. They "served our Grand Lodge in 2020 at the start of the COVID pandemic [and now can] receive their Recognition of Service."



He received cheers and a standing ovation.

Rt. Wor. Don Moran, Master of the Masters Lodge, was escorted to the East to present to the Grand Master a donation from that lodge to the Brotherhood Fund. Rt. Wor. Ian MacKenzie and Wor. Michael Centola presented a donation

to the Brotherhood Fund from the lodges of the 5th District. Rt. Wor. William Kessler, DDGM 26th District, presented a bag of checks as a donation in appreciation of the Grand Master. Wor. Brad Marston and Bro. Evan S. Fisher, recent recipient of the Master Builder's Award, had collected in "the Master's hat" at every dinner. They presented those proceeds from the collections for the Brotherhood Fund. Wor. Russell Heamer of Pilgrim Lodge, Bro. Bill Carpenter, Chair of the 1st Annual Bro. Al Boragine

Memorial Golf Tournament, donated the money collected from that tournament to the Brotherhood Fund. Em. 

Most Worshipful Grand Master, very distinguished head table, and dear brothers all,

To be standing here before you is a very special privilege and honor I never expected. Thank you, Grand Master, for your confidence and humbling appointment. Please know I will work diligently and with delight to promote the tenets of our beloved Fraternity, the undertakings of our Grand Lodge, the true joy of being a member of the Craft, and the commitment to helping each other. Having said "helping each other" and having been charged with an important oratory this evening, what I really want to do is [gives a sign of distress,] and say, you know what I'm thinking.

I must say that the true joy and honor in being a Mason began when I was 15 and joined Order of DeMolay. Whether we realize it or not, what preschool is to public education, DeMolay is to Masonry. It was started by Brother Frank S. Land, and other Masons, in Kansas City early in 1919, in response to a request for some help for a fatherless young man. The teachings of DeMolay are Masonic teachings distilled for young men to learn and grasp.

I still remember being told, when taking my initiatory degree, that "a DeMolay's word is as good as his bond." I had never heard that, but knew what it meant. "I could be counted on." I joined with five others, and we were welcomed into the brotherhood. I'm glad to say that bond still exists decades later, though life took us all in different directions. Of the 25 or so active members in our chapter, 12 of us joined the lodge at 21, and a few others, later on. Not a bad return for the lodge who supported the chapter.

I do not intend my words this evening to all be about DeMolay and why we should promote it. However, it would be wrong and ungrateful of me not to recognize its influence in my life. I would not be here tonight were it not



for the Order of DeMolay and the influence of Masonic men when I was teenager. Today, what Massachusetts DeMolay needs more than anything is Masonic men who will volunteer, a wee bit as my father would say, of their time to be Dad Advisors, to help guide young men. We know society isn't doing the job molding them! There are young men in 19 chapters across the Commonwealth now, some of whom will be leading Massachusetts Freemasonry in the coming decades. Their success needs your inspiration.

Now that you know how I feel about DeMolay, I want to switch gears. On my very first day as a Master Mason, something very positive and telling happened to me! I was attending college and working part time in the maintenance department of the First National Bank of Boston, at Devonshire and Milk Streets. My boss told me to take a cart up to see a Mr. Titus, a vice president who needed something picked up to be burned. When I arrived and told him why I was there, he looked me up and down and said, "Well, do you realize there is over ten thousand dollars in negotiable securities here that need to be destroyed and I'm not about to let any maintenance employee take them?!?"

I told him I understood and as I started to leave, he noticed the ring on my finger and asked what it was. I explained that it was a Masonic ring that had been given to me the night before by my dad. He then said he was a member of Charles C. Dame Lodge in Georgetown, and we

proceeded to chat about my raising, Masonry, and life. As I said goodbye and started to leave, he said, "Aren't you forgetting what you came for?"

I still remember my thoughts as I headed to the furnace room. Upon meeting me, he was very clearly telling me "No way!" But after a few minutes of conversation, I was entrusted to take everything. The only thing that had made a difference was that he had recognized me as a fellow Mason. It struck me very powerfully that being a member of the Craft meant something. In that moment, it was trust between two strangers who, at another level, were brothers. It was an enlightening and profound lesson to a newly raised 21-year-old. Think about it! Being in the Craft is not like being a member of the exchange club or some social group. We are trusted in ways we might not readily realize as we go about our tasks. We all know our obligations and can still repeat them in part, if not entirely. Obligations mean something. "To help, aid, and assist" is as important as saying "I love you" to someone special. But as Freemasons, we do indeed help, aid, and assist routinely because we use the tenets of Masonry in our lives every day.

Take, as an example, the Masonic equipment loan program which started in the old Malden-Melrose 7th, now the 4th District. What began in a Stoneham garage in the mid 60s has grown steadily over the past 55 years and is now in a large facility in Woburn, known throughout eastern



Massachusetts by a fair percentage of the general public. It speaks volumes of good about us, especially to those who know little or nothing about Masonry. Question: Wouldn't it be nice if there was another hospital equipment loan program in western Massachusetts so people would not need to travel so far?

Freemasonry can indeed be proud of the many and various good works done by our lodges and the appendant organizations. From the Shrine Hospitals, and Scottish Rite Learning Centers, to local lodge endeavors such as the Angel Fund. Think of our Brotherhood Fund and what it has become in the last 15 years. We can be, no, we are proud of them all!

We give of our time, our strength, our skills and talents, and our compassion. Yes, we provide money too, but it is our intent, our motivation, that makes "to help, aid, and assist" reflect well on our beloved Fraternity. Actually, we could say, if we wanted to, that we lead the way in doing for others. Masons give over two million dollars a day in charitable donations, more than any other organization in the world! If I might use a variation of the words, Massachusetts Freemasonry is leading the way in "Helping, Aiding, and assisting All."

Many Brothers were probably influenced at an early age by teachers, coaches, or Scout leaders who reinforced the correctness and necessity of responsible behavior. Many of us grew up with the concept that loyalty was as much a part of employment as ability and ethics. Social media might indicate that those ideas are passé, no longer viable, but Masons, in any lodge or country, by the oath that they took, not only uphold, but live these precepts every day. We are so fortunate to be Freemasons in this time so we can set an example of what is right and needed, now more than ever.

Early in life, I worked at Eastman-Kodak, Co., and went to train in Rochester, NY. As a new hire, I met the president of the company, Colby Chandler, a fellow New Englander from Maine. He visited a roomful of trainees and spoke with each one of us. He said something that made a huge impression on me. "Always remember when you are at a company, you are Eastman-Kodak Company." Just as "We are Freemasonry."

At this time in history, to set an example of what is right is needed more than ever. Being members of the Craft, we must always be aware that our behavior, our attitudes, must represent not only our personal values, but those to which we pledged. We must always remember that how we live daily and govern ourselves is Freemasonry in action. All we do in our seemingly mundane or insignificant lives is Masonry to others. Let them know, our beliefs are neither mundane nor insignificant! Let us all strive to live in all ways, that when our time has come, others may say, "We lived respected and died regretted." Thank you.

Garage Lodge #1

You can easily drive past it while navigating Morgan Highway in Scranton if you are not paying strict attention to Google Maps. The Prodigal Mason

It was December, and I attended a meeting for one of the organizations under what I call the Masonic umbrella. After the meeting, there was the standard and somewhat mandatory collation for the members to enjoy. That collation included crackers, cheese, cookies, cakes, and other sweet treats. It was what most would assume is a standard post-meeting light snack. To say

I have a "sweet tooth" would be a gross understatement. I love chocolate in all forms. When helping to plan meals, I normally say, "If it isn't chocolate — it isn't dessert." I thoroughly enjoyed the cookies, cakes, and other sweet treats. This would not seem like a big problem until you realize that like more than one-third of Americans, I have Type 2 Diabetes.

The next morning I checked my blood sugar. My number was so high it was like swinging that heavy hammer at a carnival. I rang the bell loud and clear. My number was higher than I had ever seen. In fact, I didn't know my blood glucose meter was capable of showing such a high number. I know better, but my love of sweets overtook the message from my mind. As it says in the Bible, "The spirit indeed is willing, but the flesh is weak."

While I was thinking about it, I suddenly realized I am not the only member who has dietary restrictions. I know Masons who are lactose intolerant. I know Masons who have to be gluten free. I know Masons who are vegetarians and even some who are vegan. Logic tells me I should just stay out of the banquet hall and then I won't be tempted. But that would take me out of the best part of a lodge meeting. I often say, "In the lodge room we perform ceremonies. In the banquet hall, we practice Masonry." It is in the banquet hall where we get to know our brothers and we get to form those "friendships that last a lifetime."

Given we don't want to ban members from the banquet hall because they have dietary restrictions, that leaves us with just one solution. We have to allow for those dietary restrictions in our collations and dinners. This means it will be up to our Junior Wardens. I have been a Master twice, but a Junior Warden just once. On my trip to becoming Master in Wamesit Lodge in Tewksbury, I went from Senior Deacon to Senior Warden. On my trip to becoming Master in Merrimack Valley Daylight Lodge, which is now in Tewksbury, but at that time was in North Andover, I spent some time as Junior Warden, but I had no traditional duties to perform. The wife of one of our members prepared the luncheon. So, I'm going to advise Junior Wardens on how to do their jobs even though I have never had to perform those duties myself.

So, what can we do? Just remember there are members with dietary restrictions and we have to plan for them. We may not know who those members are. Until this minute, I have never revealed my Type 2 Diabetes to anyone from the lodge. For our vegetarian and vegan members, we just need a platter of vegetables. But, we have to remember that vegans will not eat or drink anything from an animal, so we have to be sure there are alternatives for the liquids, such as non-dairy cream for coffee. Non-dairy options also help our members who cannot tolerate milk products.

For those members who have to eat only gluten-free goods, we have to have a supply of that as well. And the same goes for the diabetics in the banquet hall, except we are looking for sugar-free. When you are looking at sugar-free, you have to stay away from artificial sweeteners, such as aspartame, sucralose, and saccharin. There are people out there who have violent allergic reactions to artificial sweeteners. I learned this at the coffee hour at my church. My pastor cannot eat anything that contains artificial sweeteners. You should stick to plant-based sweeteners, such as Stevia, which comes from a South American plant. That is what I use.

We pledge to "help, aid, and assist" a brother, and we don't have to wait for him to ask. Sometimes we can help a brother just by keeping his welfare in mind and acting accordingly.





The Samuel Slater Experience, through a variety of exciting, unique, and innovative exhibits that run the gamut from old looms to touch-screen interactive experiences, brings the past alive for young and old.

Constructed of fiberglass, the individual sheep have been painted in a variety of colors, some featuring attachments that represent businesses or organizations in the Webster, Oxford, and Dudley areas. Bristol Lodge A.F. & A.M. 225th Anniversary Celebration

On June 14, 1797, the Grand Lodge of Massachusetts issued a charter in the name of Bristol Lodge F. & A.M., signed by the Grand Master, Most Worshipful Paul Revere, which specified that the lodge was to be located in Norton, MA. It was the twentieth lodge to be organized in the Commonwealth under the new Grand Lodge and the seventeenth of 23 'Paul Revere Lodges,' chartered during his administration from 1795 to 1797. Through a series of relocations and the expansion of Freemasonry in Massachusetts, Bristol Lodge landed in its current location in North Attleboro, MA, in 1928.

On June 4th of this year, Bristol Lodge celebrated its 225th Anniversary, which was attended by Most Worshipful Richard Maggio and his suite from Grand Lodge in Boston. Upon opening the lodge, all visitors, guests, and Freemasons formed a procession and walked across the street to a gazebo in the town park. A carpet ceremony was held inside the gazebo to re-dedicate the lodge. Following the re-dedication and closing of the lodge, the attendees went back across the street for a celebration in the function room. There were appetizers, raffles, 225th Celebration items for sale, and live music performed by Brothers of the Craft. Overall, there were about 175 attendees at this event. As DDGM Bro. William Cheetham said, "It was a great day for Freemasonry."

Masonic building. In doing so, he prophetically said, "The cornerstone of the contemplated edifice has been duly tried and is square, level, and plumb. Safely may it rest, a symbol of the permanence of justice and truth!"

A short 12½ months later, on October 6, 1897, Grand Master M. Wor. Charles Carroll Hutchinson followed suit and performed a traditional Masonic dedication ceremony, and the building was open for business. One hundred twenty-five years later brings us to 2022, so the building association and the nine Masonic bodies meeting in the building decided a rededication was in order. M. Wor. Bro. Maggio and his line of officers ably conducted the carpet ceremony in the main lodge room to a crowd of nearly 100. The Grand Master was received by a committee consisting of the five presiding Masters of the five Blue Lodges that meet in the building, chaired by the Vice President of Newton Masonic Associates (the building association). Once in the East, the Grand Master also recognized the presiding officers of Newton Royal Arch Chapter, Cryptic Council of Royal and Select Master Masons, Gethsemane-DeMolay Commandery of Knights Templar #7, and Palestine Chapter No. 114 Order of the Eastern Star, who also meet in Newtonville.

Master's Work

Q: I have heard the expression "Master's Work" referring to ritual. What does that mean?

As we look at our cipher books, we are all familiar with the notation before spoken words by the Officer who has that line, such as J.D., S.D., and so on up to W.M. (Worshipful

Master). Simply put, Master's Work is anything with the prefix W.M.

Q: Who is eligible to do Master's Work?

A: A Master or Past Master of a particular lodge of any jurisdiction recognized by this Grand Lodge may participate in the ritualistic work of a lodge of this jurisdiction upon the invitation of its Master or Acting Master, provided that the work is done in accordance with the ritual of this Grand Lodge. Also, a Warden shall not occupy the Master's chair in any lodge other than his own. (Constitutions and Regulations..., 333 Work: Participation by Masters.)

Q: I have served as Master in more than one lodge

and was presented a Past Master's Jewel from each. Should I wear them? Is it permitted to wear them both?

A: The answer to "Should I?" is no. With the explanation in Massachusetts Masonic Protocol, Section 2.3, it is strongly recommended that if a Past Master has two Past Master's jewels, he refrain from wearing both at the same time. It is redundant and serves no practical purpose. But, the answer is yes. You may have a Past Master's Jewels that hold a very special meaning to you personally. But there is a limitation to the number of jewels, medals, and awards that can be worn, and their position on your tux or suit. We do not have enough room in this article to relay all of this information, but you may find it very informative by referring to Massachusetts Masonic Protocol. You do not need to purchase the book. You can download it from our web page, MassMasons.org. Once logged in, on the opening page, you will find it under Protocol and Conduct. [The Constitutions and Regulations... is also available online. In the top left corner, click on the three horizontal lines.]
